#### Introduction

Encana Corporation is the owner and operator of the Deep Panuke natural gas field in Nova Scotia's offshore. Natural gas from Deep Panuke is processed offshore at the Production Field Centre (PFC) with sales gas transported to market via a subsea pipeline making landfall at Guysborough County, NS. The PFC is located approximately 250 km southeast of Halifax.

Encana is a leading North American energy producer that is focused on developing its strong portfolio of resource plays, held directly and indirectly through its subsidiaries, producing natural gas, oil and natural gas liquids (NGLs). Encana is committed to providing opportunities for Nova Scotian and Canadian companies through employment, procurement and contracting on an internationally competitive basis, with full and fair opportunity for Nova Scotians and Canadians, and first consideration to Nova Scotians where competitive on a best value basis. Companies who have been invited to tender will be required to complete a Canada-Nova Scotia Benefits Questionnaire, and demonstrate their commitment to and compliance with Encana's requirements regarding Canada-Nova Scotia Benefits, during the tender process.

#### Scope of Work

Encana Corporation seeks qualified, experienced companies to provide rock material and services to place the rock within Encana supplied filter units. Each filter unit will hold 4 metric tonnes of rock and total units required are expected to be 185.

The rock diameter for filling each unit shall be 100mm with a minimum and maximum size of 50mm and 150mm respectively. The rock shall be rounded and free of sharp edges.

Company shall deliver the filter units to Encana's supply base located in Dartmouth, Nova Scotia, or alternatively to a specified quayside location in the Strait of Canso area.

Encana will free issue the filter units and production frame approximately the first week of May, 2015. Company to deliver the complete filter units to Encana approximately mid-June, 2015.

## Requirements

- 1. Interested parties are required to have an implemented Quality Management System that complies with the requirements of the ISO-9000 series of Standards (or equivalent) and a Safety Management System(s).
- 2. All work carried out for Deep Panuke shall comply fully with Canada-Nova Scotia Offshore Petroleum Board Regulations.
- 3. Contractors shall have previous experience with carrying out the work similar to that specified by this EOI.

Encana will select qualified bidders using the responses to this EOI as a guide. Any eventual list of Bidders will be posted on the Encana website and other industry websites. Encana reserves the right to select more than one Contractor to execute the above Scope of Work.

Encana is under no obligation to proceed with a Request for Proposal as a result of this call for Expression of Interest. Respondents that qualify will be invited to participate in the event proposals are solicited.
