GENERAL

Encana Corporation (Encana) is the owner and operator of the Deep Panuke natural gas project in Nova Scotia's offshore. The project includes facilities required to produce and process natural gas from the Deep Panuke field, located approximately 175 kilometres offshore Nova Scotia, and transport sales quality gas, via subsea gas export pipeline (GEP), to Goldboro, Nova Scotia for further transport to market via the Maritimes & Northeast Pipeline.

Encana hereby invites interested companies to indicate their interest in providing civil works services at the onshore pipeline facility at Goldboro relative to the Deep Panuke decommissioning project as described herein. The facility is jointly regulated by the Canada-Nova Scotia Offshore Petroleum Board (CNSOPB) and the National Energy Board (NEB). Respondents are advised that the Work shall comply fully with all regulatory requirements including those of the CNSOPB and the NEB. Respondents shall also be required to comply with the Canada Nova Scotia Offshore Petroleum Resources Accord Implementation Acts including but not limited to the Benefits requirements as set out in Section 45.

Encana is committed to providing opportunities for Nova Scotian and Canadian companies through employment, procurement and contracting on an internationally competitive basis, with full and fair opportunity for Nova Scotians and Canadians where competitive on a best value basis, and first consideration to Nova Scotians. Pre-qualified companies will be required to complete a Canada-Nova Scotia Benefits Questionnaire and demonstrate their commitment to and compliance with Encana's requirements regarding Canada-Nova Scotia Benefits, during the tender process.

Encana is a leading North American energy producer that is focused on growing its strong portfolio of diverse resource plays producing natural gas, oil and natural gas liquids. By partnering with employees, community organizations and other businesses, Encana contributes to the strength and sustainability of the communities where it operates. SCOPE OF WORK

Pursuant to decommissioning of project facilities, Encana will engage a contractor for the pigging and flushing of the GEP from the Goldboro site in Q2/Q3 2019. Encana seeks qualified, experienced contractors to provide Onshore Civil Work and Support Services to support the GEP pigging and flushing program.

The scope of work is summarized as follows:

- General civil works and support services as required (to include);



- Excavation and earth removal to provide access to buried flanged connections on the GEP.
- Grading and site reinstatement, site clean-up and removal of equipment / materials as required.

The pipeline onshore facilities is designed and constructed in accordance with the CSA Z662 standard and the NEB Onshore Pipeline Regulations and is subject to inspection by the NEB and Encana.

Interested parties must include provision of all necessary personnel and equipment to complete the entire scope of work.

Schedule for the Work:

It is anticipated that the Work will be awarded in January of 2019 and that work will commence in late Q2 / early Q3 2019.

GENERAL REQUIREMENTS

EOI respondents are required to have an implemented EH&S Management System and a registered Quality Management System (complete with a current certificate issued by a recognized third party that certifies that the Quality Management System meets the requirements of the ISO 9001). Respondents are also notified that the Work carried out on Deep Panuke shall comply fully with all regulatory requirements and CSA standard Z662.

Respondents are requested to provide a brief Company profile, contact details, managers and key personnel, a description of equipment and resources, and a summary of related (and relevant) experience on past projects which are similar in scope including details of Respondent's Nova Scotia and Canadian capabilities.

Interested firms are requested to demonstrate their capabilities and experience via a formal response to this EOI and the **Prequalification Questionnaire**, which can be obtained from the email address provided below.

Encana will select qualified bidders using the respondents to this EOI as a guide. Any eventual list of Bidders will be posted on the Encana website and other industry websites such as the Maritimes Energy Association bulletin.

Encana is under no obligation to proceed with a Request for Proposal as a result of this EOI Only those respondents deemed acceptable by Encana will be invited to participate in the event Proposals are solicited. Encana also reserves the right to award more than a single contract resulting from a Request for Proposal.

Expressions of Interest must be received on or before **October 29, 2018, 2:00 PM Atlantic time.**
