GENERAL

Encana Corporation (Encana) is the owner and operator of the Deep Panuke natural gas project in Nova Scotia's offshore. The project includes facilities required to produce natural gas from the Deep Panuke field, located approximately 175 kilometers offshore Nova Scotia. Encana ceased production from Deep Panuke in 2018 and has begun the work required for decommissioning activities.

Encana will no longer require various pieces of office furniture, workstations, and mobile shelving units and is seeking expressions of interest from companies who may be interested in acquiring this surplus equipment, which is expected to become available in two phases, phase one in Q4 2019 and phase two in Q3 / Q4 2020.

Companies interested in any of Encana's Deep Panuke office materials listed below are requested to express their interest to receive a future formal bid package. Encana reserves the right to issue individual surplus packages for bid, dependent on which alternative offers the best value to Encana. Encana reserves the right to make the final determination of which material may be packaged for bid and which firms will be invited to bid.

All surplus materials will be offered on an "AS IS, WHERE IS" basis at Encana's offices downtown Halifax. The successful Purchaser will be responsible for dissembling and removing the purchased materials. Due to building restrictions, removal can only take place on weekends or on weekdays, after 6 PM. All other handling and transportation costs shall also be the responsibility of the successful Purchaser. Successful Purchasers will be required to make payment by certified cheque, prior to taking delivery of materials.
