#### GENERAL

Encana Corporation (Encana) is the owner and operator of the Deep Panuke natural gas project in Nova Scotia's offshore. The project includes facilities required to produce natural gas from the Deep Panuke field, located approximately 175 kilometers offshore Nova Scotia. Encana ceased production from Deep Panuke in 2018 and has begun the work required for decommissioning activities.

The decommissioning of the Deep Panuke facilities will include the disposal of surplus unused Halliburton Downhole Completions components related to the Project's Well Completions Program in 2010. These surplus components are currently located in Dartmouth, NS and available for sale in the Fall of 2019.

Companies interested in any of Encana's Deep Panuke Downhole Completions components listed below are requested to express their interest to receive a future formal bid package. Encana reserves the right to issue individual surplus packages for bid, dependent on which alternative offers the best value to Encana. Encana reserves the right to make the final determination of which material may be packaged for bid and which firms will be invited to bid.

All surplus materials will be offered on an "AS IS, WHERE IS" basis at Encana's warehouses and shorebase in Dartmouth, NS. Encana will be responsible to load materials on Purchaser provided transportation. All transportation costs shall be the responsibility of the successful Purchaser. Successful Purchasers will be required to make payment by certified cheque, prior to taking delivery of materials.
