



# **DEEP PANUKE PROJECT**

### **EXPRESSION OF INTEREST (EOI): Medical Services**

## GENERAL

**SBM Nova Scotia Contractors Inc.** was awarded by Encana Corporation the Production Field Centre (PFC) Start Up and Operations Contract- for the Deep Panuke offshore gas development project.

The PFC, which contains all of the main facilities, is located approximately 250 km southeast of Halifax, Nova Scotia, Canada approximately 47 km west of Sable Island and in approximately 44 metres water depth.

The PFC will be capable of producing up to  $8.5 \times 106 \text{ m3/day}$  (300 MMscfd) of natural gas from subsea wells. Each subsea well has its own dedicated flowline and umbilical. The Deep Panuke reservoir fluids contain H<sub>2</sub>S and CO<sub>2</sub> which will be removed from the fluid stream during processing on the PFC and disposed of into a dedicated subsea acid gas injection well. The market ready processed gas is exported to shore via a single subsea pipeline with landfall close to Goldboro, Nova Scotia and onward interconnection with the Maritimes and Northeast Pipeline (M&NP) for markets in Canada and the United States. The subsea export pipeline is approximately 176 km in length.

## **SCOPE OF WORK**

SBM Nova Scotia Contractors Inc. is seeking qualified companies for the supply of the following Scope of Work for its Production Field Centre as per the below listed requirements:

#### MEDICAL SERVICES

- Provide an offshore medic for the Production Field Centre on a rotational basis. One position, two persons two weeks' on/two weeks off.
- Provide a 24 hour manned on call physician help line to assist the PFC medic and manage the shore side support of Medivac responses including ambulance and hospitalization.
- Provide a Medivac response team that will travel by helicopter to the PFC. Medivac team to be available 24/7 and within a one hour response time.
- Provide and maintain Medivac equipment at the heliport in a continuous state of readiness.
- Maintain the PFC hospital and supply drugs and medical instruments/equipment as required.
- Provide onshore Medical support including employee medicals and assessments.

Respondents must demonstrate previous experience in providing this scope of work for an offshore installation located in Canada.

## PROJECT SCHEDULE

A Request for Proposal (RFP) together with relevant specifications will be issued to a list of Bidders chosen from the responses to this EOI. Issue of the RFP and award of contract are expected in the first half of 2014.

## **EXPRESSION OF INTEREST REQUIREMENTS**

EOI respondents are required to have the following implemented (i) Documented Quality Management System (ii) Documented Safety Management System that complies with their respective national HSE regulation requirements. Respondents are also advised that the Work carried out on the Deep Panuke Project shall comply fully with Canada Nova Scotia Offshore Petroleum Board Regulations.

Interested firms are requested to demonstrate their capabilities and previous experience on similar size projects via a formal response to this EOI and the Prequalification Questionnaire, which can be obtained from BIDS Nova Scotia at the address provided below.

SBM Nova Scotia Contractors Inc. will select qualified bidders using the respondents to this EOI as a guide.

Pre-qualified companies will be required to complete a Canada–Nova Scotia Benefits Questionnaire, and demonstrate their commitment to and compliance with SBM requirements regarding Canada–Nova Scotia Benefits, during the tender process.

Expressions of Interest must be received on or before **December 11, 2013, 4:00pm AST**.
