## GENERAL

**SBM Nova Scotia Contractors Inc.** (SBM NS) operates the Production Field Centre (PFC) for the Deep Panuke field on behalf of Encana Corporation.

The PFC, which contains all of the main natural gas processing facilities, is located approximately 250 km southeast of Halifax, Nova Scotia, Canada approximately 47 km west of Sable Island and in approximately 44 metres water depth.

The PFC is capable of producing up to  $8.5 \times 106 \text{ m3/day}$  (300 MMscfd) of natural gas from subsea wells.  $H_2S$  and  $CO_2$  are removed from the fluid stream during processing with market ready gas exported to shore via a subsea pipeline. An interconnection with the Maritimes and Northeast Pipeline (M&NP) system transports the gas to markets in Canada and the United States.

SBM NS is committed to providing opportunities for Nova Scotian and Canadian companies through employment, procurement and contracting on an internationally competitive basis, with full and fair opportunity for Nova Scotians and Canadians, and first consideration to Nova Scotians where competitive on a best value basis.

# SCOPES OF WORK

SBM NS is seeking qualified companies for the provision of Ad Hoc Labour Support Services for its Deep Panuke Production Field Centre (PFC). These Services are divided into three distinct Scopes of Work, based upon the various labour requirements of Deep Panuke PFC: Maintenance / Production Support, Fabric Maintenance Support and Campaign Coordinator Support. All scopes will be on an "as required" basis. Respondents should provide information to show their ability to provide personnel and equipment based on the following. Respondents may indicate interest in provision of any or all scopes outlined below.

Trades personnel shall be fully qualified, with experience and technical qualifications documentation available, trained per CAPP and CNSOPB regulations for work in Nova Scotia offshore oil and gas industrial sector.

#### A) Ad Hoc Maintenance / Production Labour Support

Supply of qualified Journeymen trades personnel, on an ad hoc basis, to complete work as directed by SBM Maintenance and Production personnel aboard Deep Panuke PFC. The following disciplines are required:

- Electricians preferably including Compex or equivalent certification
- Instrument Technicians / Technologists
- Mechanics / Millwrights
- Pipefitters / Welders
- HVAC Technicians
- Production Technicians / Gas Plant Operators

#### B) Fabric Maintenance Support

- Supply of qualified Journeymen trades personnel, on an ad hoc basis, to complete Fabric Maintenance work as directed by SBM Maintenance personnel aboard Deep Panuke PFC. The following disciplines are required:
  - Scaffolders
  - Painters
  - Insulators
  - Coaters
  - Remote Access Technicians IRATA certified
- Supply of scaffolding materials that meet applicable specifications and requirements for work on platforms located offshore Nova Scotia;
- Supply of scaffold engineering services; and
- The supply of specialized equipment related to the application of insulation or coatings.

#### C) Campaign Coordinator

SBM will require the services of a Campaign Coordinator to assist in the planning, preparation and execution of work scopes outside of regular maintenance activities. This person will work both onshore and offshore and liaise with Operations Engineering, Maintenance and Production in order to ensure effective and efficient execution of work scopes.

## **PROJECT SCHEDULE**

A Request for Proposal (RFP), together with relevant specifications, will be issued to a list of Bidders chosen from the responses to this EOI. Issue of the RFP and award of a contract/contracts are planned for Q1 2016.

## **EXPRESSION OF INTEREST REQUIREMENTS**

EOI respondents are required to have the following implemented (i) Documented Quality Management System and (ii) Documented Safety Management System that complies with their respective national HSE regulation requirements. Respondents are also advised that the Work carried out on Deep Panuke shall comply fully with Canada Nova Scotia Offshore Petroleum Board Regulations.

Interested firms are requested to demonstrate their capabilities and previous experience on similar size projects via a formal response to this EOI and the Prequalification Questionnaire, which are to be obtained from BIDS at the address provided at the bottom of this notice.

SBM NS will select qualified bidders using the respondents to this EOI as a guide.

Pre-qualified companies will be required to complete a Canada–Nova Scotia Benefits Questionnaire, and demonstrate their commitment to and compliance with SBM requirements regarding Canada–Nova Scotia Benefits, during the tender process.

Expressions of Interest must be received on or before January 19, 2016, 4:00pm AST.
