GENERAL

SBM Nova Scotia Contractors Inc. (SBM NS) operates the Production Field Centre (PFC) for the Deep Panuke field on behalf of Encana Corporation.

The PFC, which contains all of the main natural gas processing facilities, is located approximately 250 km southeast of Halifax, Nova Scotia, Canada approximately 47 km west of Sable Island and in approximately 47 metres water depth.

Respondents are advised that work carried out on Deep Panuke shall comply fully with all applicable regulatory requirements. Respondents shall also be required to comply with the Canada Nova Scotia Offshore Petroleum Resources Accord Implementation Acts including but not limited to the Benefits requirements as set out in Section 45.

SBM NS is committed to providing opportunities for Nova Scotian and Canadian companies through employment, procurement and contracting on an internationally competitive basis, with full and fair opportunity for Nova Scotians and Canadians, and first consideration to Nova Scotians where competitive on a best value basis. Pre-qualified companies will be required to complete a Canada-Nova Scotia Benefits Questionnaire and demonstrate their commitment to and compliance with the Canada-Nova Scotia Benefits requirements, during the tender process.

SCOPE OF WORK

SBM Nova Scotia Contractors will be looking to procure various **Piping Bulks** for Deep Panuke Production Field Centre (PFC) Decommissioning. The various types of these materials may include, but are not limited to:

- Blind Flanges various sizes up to 28", meeting ASME B.16.5
- Gaskets various sizes up to 28" including soft iron, graphite, flexitallic
- Paddle & Spectacle Blinds various sizes meeting ASME B16
- Stud Bolt c/w 2 Nuts H=D 2 316 SS Washers ASTM A320-L7M ASTM A194-7M Xylar-Xylan Coated
 B01N various lengths and diameters up to 3".
- Ball valves various sizes up to 4", ASME B16.5
- Flexible Hoses ½" to 3", various pressure rating up to 20 barg

- Swagelok Tube Fittings, ½" to 1"
- Instrument Block and Bleed valves ½"
- Pressure gauges 100mm Dia, various ranges up to 10 bar range

PROJECT SCHEDULE

SBM NS is looking to enter into Standing Offer Agreements with qualified companies to have agreements in place so call-offs for materials may be done on an as-required basis during Decommissioning. Once respondents to this EOI have been qualified by SBM NS, they will be asked to provide pricing lists for the types of materials that SBM can call up against as needed.

EXPRESSION OF INTEREST REQUIREMENTS

EOI respondents are required to have the following implemented (i) Documented Quality Management System and (ii) Documented Safety Management System that complies with their respective national HSE regulation requirements. Respondents are also advised that the Work carried out on Deep Panuke shall comply fully with all applicable regulations.

Interested firms are requested to demonstrate their capabilities and previous experience on similar size projects via a formal response to this EOI and the Prequalification Questionnaires which are to be obtained from SBM Nova Scotia Contractors Inc Procurement department as indicated below. A Confidentiality Undertaking will be provided to respondents and required to be executed prior to receiving further documentation.

SBM NS will select qualified companies using the respondents to this EOI as a guide.

Qualified companies will be required to complete a Canada-Nova Scotia Benefits Questionnaire and demonstrate their commitment to and compliance with SBM requirements regarding Canada–Nova Scotia Benefits.

Expressions of Interest must be received on or before Thursday August 9, 2018, 4:00pm AST.
