GENERAL

DOF Subsea Canada Corp (DOF) hereby invites interested parties to submit an Expression of Interest (EOI) and complete the Prequalification in connection with DOFs Removal of Subsea Structures, Transport & Disposal Scope of Work as part of the Deep Panuke Project on behalf of Encana Corporation in Nova Scotia, Canada.

SCOPE OF WORK

DOF Subsea Canada requires the services of qualified and experienced contractors for the provision of the following services:

Grillages, frames and seafastening material will be utilized to outfit a construction vessel for removal and transport of 5 off Wellheads Protection Structures, 1 off SIV structure, and various project tools/equipment.

Indicative estimates of quantities of items to be procured and fabricated are:

- Greater than 150 linear meters of W-Beam ranging from W8 to W12;
- Fabrication of 6 off grillages at 3m x 12m;
- Various seafastening plates/clips;
- Miscellaneous components such as steps, railings, grating, etc.

Contractor shall express interest in Option 1 and/or Option 2:

Option 1: Fabrication

All labour, tools, equipment and consumables necessary to complete the work and ensure that all equipment and services supplied meet all statutory requirements, codes of practice and applicable specifications. The scope of work may include, but not be limited to:

- Procurement and pre-fabrication of grillages/frames and seafastening materials. Material certificates and traceability required for all material;
- Structural welding/fabrication performed by C.W.B certified welders conforming to CSA W59-03 (R2008) & CSA W47.1-09;
- Blasting and painting;
- Equipment load testing;
- NDE inspection, MPI, UT and MT;
- Loadout of pre-fabricated grillages/frames and seafastening materials to port of mobilization;
- Reporting related to safety, quality, progress, schedule, cost and benefits;
- Calculations, drawings and documentation including regulatory certificates, inspection reports, and periodic progress reports, as applicable.

Fabricated grillages/frames and sea fastening material to be delivered to port of Halifax in Nova Scotia in September 2020.

Option 2: Seafastening

All labour, tools, equipment and consumables necessary to complete the work and ensure that all equipment and services supplied meet all statutory requirements, codes of practice and applicable specifications. The scope of work may include, but not be limited to:

- Sea-fastening of equipment, grillages and support frames as detailed in option 1 onboard construction vessel;
- Removal of equipment, grillages and support frames as detailed in option 1 from construction vessel;
- NDE inspection, MPI, UT and MT;
- Cleaning of decks to original condition after removal;
- All steelwork to be performed by C.W.B certified welders conforming to CSA W59-03 (R2008) & CSA W47.1-09;
- Reporting related to safety, quality, progress, schedule, cost and benefits;
- Calculations, drawings and documentation including regulatory certificates, calibration reports, inspection reports, and periodic progress reports, as applicable.

Initial quayside seafastening location will be port of Halifax. Interim quayside and demobilization quayside is yet to be finalized, but it will be a port in Nova Scotia in September 2020.

- Summary of QA system that meets the requirements of ISO 9001, and a material traceability system in compliance with specifications and approved procedures;
- Summary of HSE system that meets the requirements of all Safety, Security, Health and Environment (SSHE) specifications and safe work practices of DOF, as well as any and all Federal/Provincial safe work requirements;
- Description of experience operating under and familiarity with, the benefits provisions of the Canada-Nova Scotia Offshore Petroleum Resources Accord Implementation Acts, and experience with any similar regimes in other parts of Canada or internationally;

- Acknowledge that responsible management personnel have read, understand and will support requirements to comply with Section 45 of the Canada-Nova Scotia Offshore Petroleum Resources Accord Implementation Act.

Interested parties may be subjected to technical / experience audits, quality audits, and/or safety assessments for the purposes of validating programs and procedures.

Respondents that are not already an approved supplier of the DOF Group will be required to complete a qualification questionnaire.
